Candidates filing as a Libertarian candidate will only appear on the general election upon approval of the Libertarian Party of Ohio's petition forming a minor party pursuant to Directive 2018-16, certification of the candidate's petition, and inclusion as a candidate on the Libertarian Party's slate of candidates filed with the Ohio Secretary of State no later than 75 days before the general election.
